1. Driver and documentation

The Renter declares and guarantees that they are at least 28 years old and hold a valid Category B driving licence with a minimum of 5 years of driving experience. The renter must provide an ID card, NIE or passport, address, telephone number and email address. A second driver is included at no additional cost and must provide the corresponding documentation.

2. Reservation and payment

The reservation will be confirmed upon payment of a €100 deposit.

Payments may be made by bank transfer or Bizum.

The remaining balance may be paid by bank transfer before the rental period begins or in cash when collecting the vehicle.

3. Insurance and security deposit

The motorhome is covered by valid insurance. The insurance excess is €300. A refundable security deposit of €500 is required. If paid in cash, it will be returned upon vehicle return. If paid by bank transfer, it will be refunded on the next working day after vehicle inspection.

4. Fuel and mileage

The motorhome must be returned with the same fuel level as when collected. Rentals of up to 3 days include 100 km per day. Rentals longer than 3 days include 150 km per day. Unlimited mileage is available for an additional €10 per day.

5. Cleaning and sanitation

The motorhome must be returned with the toilet cassette emptied, the grey water tank emptied and the fresh water tank full. Failure to do so will result in a €30 cleaning charge.

6. Vehicle use

The Renter agrees to use the motorhome responsibly and in accordance with applicable laws.

Smoking inside the vehicle is not permitted.

7. Fines and penalties

Any fines, penalties or traffic violations incurred during the rental period shall be the sole responsibility of the Renter.

8. Cancellation

Cancellations made more than 30 days before the rental start date are eligible for a full refund. Cancellations made less than 30 days before the rental start date are non-refundable.

9. Inspection and return

Photos and videos may be taken before and after the rental period to verify the condition of the vehicle.

10. Territory of use

The motorhome may be driven within Spain and, with prior authorization from the Lessor, in certain European countries. Any travel outside Spain must be communicated in advance. Authorization will depend on the rented model and the planned itinerary.
